Council President Berglund stated this chemical starts working in a matter of hours. The connector from Simpson to Central is flat and stops the water. We designated this and other area to etch out the roots from the inside, and the herbicide should keep roots from destroying the pipe.

Councilman Gabriel confirmed with Mayor Silver that the pipes are tv'd to confirm their deterioration.

Mayor Silver responded to Councilman Asay on how long it takes to breakdown the root, by stating this starts to work within a matter of hours. It all breaks down and biodegradable. We spent about \$15,000 from Brick MUA, and this is part of the process to maintain our sanitary sewer. He anticipates this lining to last about 50 years.

Councilwoman Snow asked about the lasting of the lining in addition to pollution liability.

Mayor Silver state all vendors require insurance. The other vendor did not provide proof of insurance. As long as they provide the proper paperwork, the Borough is covered.

ASAY:

Painting is the next phase, and the Borough will need some type of deterent to keep the birds out. Mr. Asay stated his concern over the legal battle ensuing with Dillon's Creek, and the need to fix the groin. Several agencies are now involved with countersuits. With regard to Park Avenue, Mr. Worthington plans to repair the end of the road and provide public access; with a meeting with his engineer in the future. Mr. Asay stated Maser Consulting conducted a speed analysis of the

Borough roads to determine appropriate speed. He stated most streets list 25 mph as the appropriate speed, with a few streets slightly differing.

GABRIEL

The Councilman asked if the Borough has a long range plan to address building improvements.

Mayor Silver stated that Council President Berglund completed a three year plan, but did not address individual buildings.

Mr. Gabriel stated his interest in pursuing this and plans to speak with the Governing Body to initiate a plan for budget purposes.

Mayor Silver thanked him and stated the Borough plans on conducting an energy audit through a state program that will pay 70% of the audit; and further plan to focus on one project at a time

SNOW

The Councilwoman thanked Council President Berglund for the grant information. She added that the Historic Preservation meeting went well, and was well attended in addition to being very informative. The Christmas Tree is now taken down at Camp Walk. She ended her report stated that they are looking further at IT Solutions, and welcomed information from the Borough Clerk.

6. COUNCIL REPORTS

Mr. Asay did a brief demonstration on the new type of water meters that are available and that the current ones the Borough residents have are beyond their life span. The Borough is spending \$50 to \$100 to repair meters right now. The method to read the meters requires a DPW employee to walk up to the house and put the wand to a touchpad on the outside of the house to acquire the reading. The new meter

is approximately \$120 and has a life span of 20 years but the battery warranty is pro-rated after ten years. This new meter would be read by either DPW just driving up and down the street or by placing an antenna on top of the water tower and it is sent directly to the computer used for billing. Further discussion was held on the costs, types of meters and ways to obtain readings.

Mr. Gabriel stated that he mistakenly thought he was in charge of Public Facilities at the last meeting but he is willing to help Mr. Asay in that area. Mr. Gabriel further stated that there is a meeting on March 1st regarding the radio communications switching from 500mhz to 700mhz which the Borough should start planning for the cost of this as soon as possible.

Mr. Berglund stated that he has a meeting scheduled with Maser regarding grants and funding for the new water meter system next Wednesday (February 21st). Mr. Berglund also reported that the re-assessment inspections are approximately 63% done.

Ms. Wudzki stated that Officer Tyler Gebler submitted his resignation and obtained a full time position with East Windsor. She thanked him for his service and wished him good luck. Ms. Wudzki said that there will be a mini Farmer's Market on 5/14/18 for vendors who have spring items such as flowers to sell and then the Farmer's Market will start up on June 4th and run through end of Sept. in the same format and the hours will be 2pm to 7pm.

Ms. Thompson stated that she was out near the boardwalk and saw a couple feeding the birds and stopped to explain how unhealthy it is for the birds and that there is an ordinance in place not to feed them. She also told them the police department is monitoring this. Ms. Thompson submitted a street light outing on line to JCP&L and it has been 8 days and it is not repaired. She is waiting to see how long it takes before she has to go to the next step or contact Maria Sessa to ensure it is done. Ms. Thompson attended the Island Heights Board of Education meeting and they discussed the issue with parents parking and blocking driveways on Summit Ave. and they felt the police need to do the enforcement on this issue. Ms. Thompson explained that the bond referendum of 2.9 million the work is mostly complete and they have a balance at this time of \$525,000 which they will spend down to about \$300,000. This \$300,000 will be used to pay down the debt interest. Ms. Thompson also reported that March 14th is Theater week and March 22 is the STEAM Fair all are invited to attend.

Ms. Thompson also reported that she and Ms. Snow are moving along with the new website. They both briefed the Mayor on cloud based hosting and the cost associated with it. Hopefully by March they will have the total cost and present it to the Council. Ms. Thompson said she has been proofing the pages of the website that have been completed. Ms. Snow said they are working to maintain the emails so we do not lose anything in the transition phase. They are also working on the IT landscape in which they surveyed all departments to see what the needs and issues are. Ms. Snow further stated they are working on the IT consult and RFP to get service we need to catch up with other local governments.

Ms. Snow reported that she attended the Business Roundtable in South Toms River that Joseph Kostecki, our Clerk held last month and there was an incredible turn out with standing room only. Ms. Snow commended Joseph Kostecki on a job well done.

Ms. Snow reported that they are working on a Founder's Day with Recreation including Christine Gabriel and Melissa Wudzki also Susan Cowdrick who played a large part in the 100 year Celebration. The plan is to have a lot of events in town which include a parade around the river ending at Memorial Field where there will be a fair with maybe local vendors, food trucks, etc. Ms. Snow said they have reached out to the Artist Guild, Peto Museum and others to see if they would like to hold their own events or participate in the town's event. Tentative dates are 7/27 – family movie and open the time capsule from the 100 year celebrations; 7/28 – the parade and fair; 7/29 Church service and bury the new time capsule.

Ms. Gabriel spoke that they are actively seeking sponsors to help cover the costs to avoid the town having any responsibility with costs. She also stated that they are working hard to make it a safe environment so the children can enjoy the fair or go to the playground.

Ms. Snow stated that she is working with Don Roberts on the CAPE Program which will help in archiving our old historical documents for free. Ms. Snow also said she has a Save the Date from the

Island Heights Cultural and Heritage for Wines Around the World on 34/19 @ 7pm being held at the Cafe Italia on Rt. 37 in Toms River. The cost is \$55 per person for a great cause.

Ms. Wudzki said that she forgot to mention at the last meeting at the Island Heights Board of Education that they complimented DPW on how well they have completed the snow removal and they thanked them for an amazing job.

Mayor Silver asked Mr. Asay about the Oyster Creek Nuclear Plant. Mr. Asay stated that it will be closed this year but due to the fact that there is still significant nuclear material it will still need to be guarded since it can be used as weapons material. Mr. Asay also stated that all employees were offered employment although it may require relocating and that Lacey will be taking a huge hit since this plant is 40% of their budget.

Mayor Silver asked Don Roberts for an update on the New Jersey Historic Trust. Mr. Roberts stated that they initial graphics for the signage that needs to be placed on the Wanamaker Complex in order to get the lien removed is 98% done. Further discussion was held on the lien and its meaning. Mr. Roberts said that once the sign is in place we just need to provide them with photo evidence and the lien is resolved.

7. PRIVILEGE OF THE FLOOR

Andy Parks of 121 Summit Ave. discussed the issue with the manner in which children are dropped off at the school and the dangers associated with people trying to travel on Summit Ave. Mr. Parks offered a suggestion that they reverse the one-way on Simpson Ave. and utilize that as the drop off road coming in from Lake Ave. Mayor and Council all agree that a need to resolve this and look for an alternative is necessary.

ASAY: Thanked Maria Sessa and JCP&L on their open tour, which was very informative. He stated JCP&L only employs an estimated 1,200 employees, and about 1,800 workers were on-call for the storm. In review of the landfill tonnage report, weekly recycling increased 60 tons more.

GABRIEL: none

BERGLUND: All documents for the boat dock have been submitted, with a plan for bulkheading

forthcoming. The NJDEP approved the sewer pump change. The final count didn't include Dirmitt Avenue for grinder pump and rails, and asked for a supplement by Maser. Boy Scout Island committee hasn't met and are under the gun to submit the grant for a maximum of \$35,000 by May 1st. Maser provided four proposals for shoreline enhancement, with different techniques for each enhancement.

SNOW: The Easter Egg Hunt last Sunday went well and thanked Wendy and Tamara for stuffing eggs. Founders Day event is still in planning, with a flyer to be included with tax bills. Water and Sewer now has E-Bill. The Recreation Summer Program will have Zumba this year. The Northern Ocean Recycling Center announced a new smartphone app called Recycle Coach.

THOMPSON: There is a wine tasting on April 19th for the Cultural and Heritage Foundation

WUDZKI: Thanked DPW, Police and all emergency services who worked during the last storm. Planning has started for the Farmer's Market, with dates forthcoming.

SILVER: Joe Cocoa's mom passed and therefore will not be available this coming Monday, however Ray Claudio will assist.

PROCLAMATION

DECLARING THE FIRST FRIDAY IN JUNE (June 1, 2018) AS NATIONAL GUN VIOLENCE AWARENESS DAY

This proclamation declares the first Friday in June to be National Gun Violence Awareness Day in the Borough of Island Heights, NJ to honor and remember all victims and survivors of gun violence and to declare that we as a country must do more to reduce gun violence.

WHEREAS, every day, 96 Americans are killed by gun violence and on average there are nearly 13,000 gun homicides every year; and

WHEREAS, Americans are 25 times more likely to be killed with guns than people in other developed countries; and

WHEREAS, protecting public safety in the communities they serve is our mayors' highest responsibility; and

WHEREAS, support for the Second Amendment rights of law-abiding citizens goes hand-in-hand with keeping guns away from dangerous people; and

WHEREAS, mayors and law enforcement officers know their communities best, are the most familiar with local criminal activity and how to address it, and are best positioned to understand how to keep their citizens safe; and

WHEREAS, in January 2013, Hadiya Pendleton, a teenager who marched in President Obama's second inaugural parade and was tragically shot and killed just weeks later, should now be celebrating her 21st birthday; and

WHEREAS, to help honor Hadiya – and the 96 Americans whose lives are cut short and the countless survivors who are injured by shootings every day – a national coalition of

organizations has designated June 1st, 2018, the first Friday in June, as the 4th National Gun Violence Awareness Day; and

WHEREAS, the idea was inspired by a group of Hadiya's friends, who asked their classmates to commemorate her life by wearing orange; they chose this color because hunters wear orange to announce themselves to other hunters when out in the woods; and orange is a color that symbolizes the value of human life; and

WHEREAS, anyone can join this campaign by pledging to Wear Orange on June 1st, the first Friday in June in 2018, to help raise awareness about gun violence; and

WHEREAS, by wearing orange on June 1, 2018 Americans will raise awareness about gun violence and honor the lives of gun violence victims and survivors; and

WHEREAS, we renew our commitment to reduce gun violence and pledge to do all we can to keep firearms out of the wrong hands, and encourage responsible gun ownership to help keep our children safe.

NOW, THEREFORE BE IT RESOLVED, that I, Mayor Jeff Silver of the Borough of Island Heights declares the first Friday in June, June 1, 2018, to be National Gun Violence Awareness Day. I encourage all citizens to support their local communities' efforts to prevent the tragic effects of gun violence and to honor and value human lives.

WHEREAS, Master Gardeners of Ocean County, INC. was formed in 1990 and is a non-profit organization working in cooperation with the Ocean County Board of Freeholders and Rutgers NJ Agricultural Experiment Station to promote the mission of the Rutgers Master Gardener volunteer program by utilizing research-based information to educate the public throughout Ocean County on best practices in consumer horticulture and environmental stewardship; and

WHEREAS, the Master Gardeners of Ocean County, Inc. provides services for tick identification and have tracked the tick population in Ocean County since 2010; and

WHEREAS, over the past five years, Master Gardeners of Ocean County, Inc. has tracked an increase in the tick population; and

WHEREAS, while Lyme Disease cases are reported on in the Ocean County and New Jersey area, the U.S. Department for Human Services, Center for Disease Control and Prevention has updated its

pamphlet "Tickborne Diseases of the United States 'A Reference Manual for Healthcare Providers" to include additional less known diseases that impact the health of our citizens.

WHEREAS, these additional diseases include Anaplasmosis which is most frequently reported in areas that correspond with the known geographic distribution of Lyme disease; Babesiosis which is most frequently reported from the northeastern and upper midwestern United States; Ehrlichiosis most frequently reported from the southeastern and south-central United States, from the eastern seaboard extending westward to Texas; Rocky Mountain Spotted Fever cases have been reported throughout most of the contiguous U.S.; Powassan virus infections have been reported primarily from Northeastern States and the Great Lakes region; and

WHEREAS, the Master Gardeners of Ocean County, Inc. are committed to provide tick identification and preventative information, as well as promote the awareness of diseases set forth by the Center for Diseases and Prevention to citizens of Ocean County.

NOW, THEREFORE, I, JEFFREY SILVER, MAYOR of the BOROUGH OF ISLAND HEIGHTS, COUNTY OF OCEAN, STATE OF NEW JERSEY do hereby proclaim JUNE, 2018 as TICK AWARENESS MONTH and further express sincere appreciation for the commitment and dedication demonstrated by these volunteer citizens of Ocean County.

MUNICIPAL BUDGET

Public Hearing

Bob McNeil, 237 Ocean Ave, asked for the number in which the budget will increase. Close PH:1st: Berglund 2nd: Snow, and full Council consent.

CFO stated the budget equates to a 2 cent increase based on the average home assessment of \$386,200. The average increase per household will be approximately \$77.24. The revenue base is the focus. Most of the revenue is from the tax base of residents. The overall budget will increase just over \$272,881.00 and the biggest increase is from the surplus anticipated. There are several one-shop revenues such as the surplus and cancelling of grants and miscellaneous revenue; the

Interfund was liquidated.. The Borough utilized \$1 million in surplus this year, and stated that the Borough will not have this for next year's budget. The prepayment of taxes led to less delinquent tax percentage. The reserve for insurance reimbursement will not be in the budget in the future. The UCC fees are no longer required to be collected for building and siding. As for Expenditures, both Salary and Wages, and Health Insurance increased; Post Office and Antenna lease have increased in revenue. The CFO stated that if anyone has any other revenue ideas, then please approach us. As far as expenditure side, we have increases in relation to unions, with salary and wages, health insurance. A decrease in police department as there are no longer crossing guards. The beach maintenance will decrease as there are no lifeguards. Increase in debt service, and PERS and PFRS.

Council Member Thompson asked about the debt.

The CFO stated that the debt went up about \$174,000, which represents mostly the principal on BANS. The Borough did not pay principal payments on bonds for about 5 years. These payments will substantially go up, and the CFO is evaluating how the Borough is going to pay for them, with the possibility of setting up a reserve.

Councilman Gabriel, we budget \$60,000 in engineering costs. Now the costs have skyrocketed the last three years. Last year we budgeted 60, and had to budget more at \$75k. There have been increases in contracts and raises, where the PD has \$456,557.00 last year; now budget \$610 this year. \$7,000 for Code Enforcement; now \$21,000 for this year. Shade Tree was only budgeted \$150 last year, was \$5,000 for this year; down to \$2,000 now. Next year our school referendum will hit us; a revaluation in progress, and a 2 cent increase this year. I just can't see hitting our residents with this when clearly there is money in this budget to trim.

The CFO stated that as far as engineering, everytime, all preliminary costs are charged to the budget; not the grant. The CFO has put a freeze on all new projects.

The Mayor stated a penny represents about \$34,000 in new taxes. The Borough doesn't have summer revenue that is equatable to other shore towns that helps offset the taxes.

Council Member Thompson stated her concern over the reduction of the annual contribution to the Fire Company

Councilman Asay stated he was not fond of the baseline budget calculation, and specifically regarding the annual fire company contribution. He stated that last years contribution was \$40,000 and an addition \$5,000 makes it \$45,000. When we received this year's budget, it was lowered to \$30,000. Then, after speaking with the Mayor, it was upped to \$40,000.00. Therefore this years budget is less and the increase is just not true.

Mayor Silver stated that the Borough actually gives \$62,000 total to the Fire company, which also covers LOSAP.

Council Member Thompson stated her interest in increasing the contribution by \$5,000 to the Fire Company. She further stated her request to reduce Shade Tree by \$1,500 and cut Code Enforcement to cover the \$5,000 increase in Fire.

Council Member Wudzki stated she met with the Fire Company, and they expressed at least the \$45,000 budgeted.

Council Member Thompson requested this line item be increased to \$45,000.

The Borough Clerk stated that there was a Motion and Second, and therefore Roberts' Rules do not allow for an additional motion was a First and Second were made.

The CFO stated that if this is voted down, then a resolution to amend, and additional public hearing will have to be held. And, if one line item is increasing, then another would have to decrease.

Council Member Thompson requested that the Shade Tree line item be decreased. She requested to reduce the Shade Tree line item by \$1,500 and \$3,500.00 Code Enforcement, and increase the Fire Line Item by \$5,000.00

The Mayor confirmed that the Roll Call is currently open with a First and Second on the main Budget; not the amendment. As such, he requested the Borough Clerk to proceed with Roll Call.

Bob McNeil, 237 Ocean Ave: stated he saw approximately 20 cans of paint placed down at the Public Works facility.

Mayor Silver stated he saw construction debris in the dumpster at the Fire Company, stating concern over people misusing the Fire Company's dumpster which is private and not for public use. He stated they will be looking at options to assist the fire company with this issue.

b.The use of public spaces and property subject to fees are reflected in 19-2.1 Naming of Public Docks, Beaches, Fishing Areas and Playing Fields.

- c. Fees for marriage ceremonies and/or use by the public for a private event are at a fee of \$200.
- 2. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason declared invalid or unconstitutional by any court or federal or State agency of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.
- 3. All ordinances or resolutions or parts of ordinances or resolutions inconsistent herewith are hereby repealed to the extent of such inconsistency.
- 4. This ordinance shall become effective upon publication as required by law, and will reflect the following structure:

19-2.3 Fees.

- a. Calendar year badges or tags to permit bathing, swimming, fishing or crabbing shall be provided and fees for the same shall be established by the following ranges:
 - 1. Seasonal badge or tag from \$15.00 to \$20.00. After June 1st, \$25.00 to \$35.00.
 - 2. Weekly badges \$5.00 to \$10.00.
 - 3. Monthly badges after June 1st, \$15.00 to \$20.00.
 - 4. Daily badges \$5.00 to \$8.00 per day.
- b. The use of public spaces and property subject to fees are reflected in 19-2.1 Naming of Public Docks, Beaches, Fishing Areas and Playing Fields.
- c. Fees for marriage ceremonies and/or use by the public for a private event are at a fee of \$200.

The Mayor and Council shall establish fees within the above ranges by resolution adopted yearly.

PRIVILEGE OF THE FLOOR

Judy Lessman, 21 Ensign Place. The President of the Island Heights Cultural and Heritage will be hosting a Garden Tour from June 6th through 9th, from 10am to 4pm.

Mary Judge, 255 VanSant Ave: Applied on behalf of the Borough for a Dept of Environmental Protection grant in the amount of \$1,500 for improvements to the Wanamaker Complex, including the field sign, native shrubs and a clam shell path.

Judy Lessman, 21 Ensign Place: informed the Governing Body that she has sewage backup problems, now twice in last 6 months. The Mayor stated that the Borough is inquiring about her concern.

Mayor Silver stated that residents are using baby wipes and are clogging up the sewer.

Drew Sebert (Sassafras Lane) received an email about rusty water, and asked if the Borough is considering making any water improvements.

Mayor Silver stated that improvements are being done. Currently, the Borough exhausted it's budgeted engineering costs.

Seeing no other comments, Council President Berglund motioned to close Public Comment; Seconded by Councilman Asay, and full Council consent.

COUNCIL REPORTS

ASAY: All boardwalk lights are now on. There have been five water service breaks resulting in digging up the street with Public Works. All of the vehicles were sold at auction, and Ray will be providing a breakdown of revenue from that sale. The sand has been removed at Summit Beach, and the permit to reinstall sand will take two-to-four months.

GABRIEL: Stated that he would like to see the 2018 Engineering costs.

BERGLUND: Infrastructure repairs are averaging two per week, just on water service. Areas in the Borough where geese are a problem, he encouraged the use of drones, which act as a good deterrent.

WUDZKI: There have been two Farmers Markets, and the next is June 4th; which will include the Environmental Committee, with activities for kids. Founders Day information is now available on Facebook and website. She further mentioned that Sue Caldric (Chair of Parade is asking who participating and walking), requesting if the Governing Body would like to walk behind any of the elders walking in the parade.

Jim Jablonski stated that the Yacht Club would also like to participate, and it was noted by Council Member Wudzki.

MAYOR SILVER read a letter from the County Engineer regarding speed limits and the Council's request to lower the speed, stating current enforcement does not warrant a lower speed. However, if the Island Heights Police Department conducts selective enforcement and find it warranted, they will reconsider. Additionally, the

Borough was awarded \$440,000 as part of the 2018 NJDOT Municipal Aid for improvements on West End and Lake Avenue. There also was a survey and evaluation at the bottom of Central Avenue for the gravity sewer to determine whether the sewer main ban be installed in Central Ave rather than behind the homes. However after the evaluation, the Borough Engineer recommended other options.

AN ORDINANCE OF THE BOROUGH OF ISLAND HEIGHTS, COUNTY OF OCEAN, STATE OF NEW JERSEY, PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS AND RELATED EXPENSES FOR THE BOROUGH OF ISLAND HEIGHTS AND APPROPRIATING \$735,000.00 THEREFOR AND PROVIDING FOR THE ISSUANCE OF ISLAND HEIGHT IN GENERAL IMPROVEMENT BONDS OR NOTES OF THE BOROUGH OF SOUTH TOMS RIVER TO FINANCE THE SAME. (First Reading)

The Mayor opened the floor to Council for any related questions.

Thompson: Is there a list or projects (priorities) derived from the bonds?

Mayor Silver: The water main on Lake, River and Sassafras are ready for bid. The sanitary sewer is ready for bid as the root treatment was completed; next is the lining. The soft costs have been spent here. Water Treatment (chlorine system) will convert to liquid system to alleviate clogging. We now have the chemistry to turn it into a liquid. The engineering is complete here and now we are ready for bid. There is also funds for a Public Works utility body truck

Berglund: We were requiring a new building to store materials but no longer pursuing this and everything will be stored on-site for the treatment system.

John Bendel. 2 Summit Ave: asked if capital bonds can be used to purchase vehicles?

Asay: The CFO states that we can bond for the truck but why would we? This bond ord has a 35% downpayment

CFO: from the capital improvement fund. You take a little each year so that you have the down payment when you need it. A downpayment for a bond is required. At the end of the year, we were self-liquidating and showed that we needed to have a down payment.

Asay: if we were to spend out for \$700,000. Would you anticipate this being long-term debt?

CFO: It could, if not paid off in ten years as a BAN (bond anticipation note)

If it is long-term, what would be the term?

CFO: probably 25 years.

Asay: I believe we may be paying 25 years of payments which may only last 20 years.

CFO: you wouldn't have been able to purchase this vehicle last year, and you would've had to reduce expenditures.

Gabriel: What are the list of priorities? Where is the analysis. He stated that he could not vote on a bond that doesn't specifically list the projects that will be associated with the bond.

Snow: The more we can explain, the more palpable it will be to us and the residents.

Asay: I was anticipating residents from Sassafrass to be here and complain about their water quality, and amount of iron in their water. They were told the engineering was exhausted and nothing can be done. Now, all the engineering is done and is ready to roll out? This is significantly different. In fact this is done and ready for bid.

Berglund: We didn't have the money for the analysis.

Gabriel: This is the third time in last couple years to have a bond ordinance for water and sewer without a list. I want a prioritized list. Our water quality seems to be getting worse; dozens of complaints from residents. I'm questioning one and sending a problem to other areas. There still is a problem on Maple as well. I have to clean my toilets every week and it's not from use. There's no specifics and there no list.

CFO: the water sewer repairs are running parallel to street repairs. Preliminary work is done to analyze both.

Thompson: It would be helpful to have a running list in the pipeline, and would be great to sit and understand it. We can then digest this.

Gabriel: What are we doing. Are we adding a loop and changing the direction of the flow?

Mayor: That is what happened at Jaynes.

Berglund: We spoke with the DEP with the quality of the water and understand we are placing in new pipes, and we will have problems since everything is looped; its going to happen.

Gabriel: What are we going to tell people?

Mayor: We are trying to resolve this.

Gabriel: I think we need to look at hiring more public works employees rather than paying vendors for prevailing wage.

Snow: I don't think we disagree there are problems and they are expensive. If we have a list, we have a better understanding of how to communicate with residents - such as this is what to expect, but it will be resolved.

Gabriel: I don't like the word "various" when we have a public safety emergency with our water quality.

Asay: The council has made it a priority not to dig it up. The Mayor was right also. But this was assuming all things are equal. However, all things are not equal. We need potable water.

The Mayor allowed comments from the floor.

Charles McWilliams. 209 Maple Avenue: Expressed their displeasure with drinking water. They complained in the past and wants the Borough to fix the water infrastructure. I was told to bring receipts to replace the clothes that was ruined by the water. Why should I pay for water that I can't use.

Steve Doyle. 19 Jaynes Ave: stated he's in favor of seeing a list of priorities associated with the bond, and suggested working meetings are a way to get this completed.

Thompson: Is anything funding Maple from this?

CFO: Yes. This ordinance allows for all water and sewer improvements. Whether we stop one and address all the issues, this ordinance covers all improvements that are being discussed. You need this ordinance to make these improvements. That being said, I will be meeting with the engineer on monday to discuss the list of projects and will provide that. In order to fix our water/sewer, we need a funding source.

Borough Clerk: The Clerk mentioned the Water Infrastructure IMprovement Act allows municipalities who may not have a revenue source that will allow for these improvements that is not part of a loan. You would hire a consultant, go out for bid to determine rates and partnership options from a Public-Private Partnership or full sale, or receive capital in exchange for managing the system. This process allows for options for the Borough. The cost to start this fee is an analysis as part of the consulting/engineering process. If the results of the bid return unfavorable, you don't proceed.

Thompson: That would've been really good news two or three years ago.

Clerk: I was here three years ago, and proposed it then.

Thompson; I don't believe we have all of the information we need.

Snow: We need to do something, we need more information though.

Further discussion ensued regarding the arrangement of a special meeting.

(Ord. No. 88-01 §1). The Minimum cost for first-time delinquency charge will be one hundred and fifty (\$150) dollars. The delinquency charge on the for the second offense is two hundred (\$200) dollars. The delinquency charge on the third offense is five hundred (\$500) dollars.

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason declared invalid or unconstitutional by any court or federal or State agency of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.
- 3. All ordinances or resolutions or parts of ordinances or resolutions inconsistent herewith are hereby repealed to the extent of such inconsistency.

I believe we are at the point where council should consider hiring someone to do a rate study and potentially, a private-public-partnership for water-sewer. You have an issue with iron in the water.

Moving to the Current Fund and our Court issue which I believe the Mayor is working on. Effective today, we have our Construction Office now out of Toms River. We only see a \$526 difference from what we previously collected. The beach and recreation badges are down \$6,900 dollars but still have people collecting badges on the boardwalk.

All that said, you do have a major problem with your water-sewer deficit which will need to be made up in the current fund, with a tax point at \$42,000, and with a \$100,000 deficit, this is three tax points that will be added to next year's budget.

COUNCIL REPORTS

WUDZKI: We are planning Trucktoberfest on October 13th from 11am-6pm, with a rain date on Sunday. Foodtrucks, vendors, breweries, and activities for the kids. A great time and a needed fundraiser for our fire department. There are a couple more week left for the Farmers Market, with a slight change in hours.

THOMPSON: The Grade School board is meeting on the 12th; October meeting on 10th. The High School has their meeting on September 20th at 7pm and October 18th at 7pm.

There was one animal control measure taken for a dead possum. Maybe I can speak with Councilman Asay and see if DPW can assist with in the future as the bill came to \$95.

SNOW: This year there was not a document shredding event. However, we are going to work with the county for next year and changing the day and location to make it work. I'll be happy to sit with Sean and Melissa to work with DPW and have it on a weekday so there is no overtime; possibly at Wanamaker rather than DPW. I help teach the Master Composting class, and focusing on community gardens. It is free for county residents. Its oct 27 and nov 3rd It's only two saturdays and we provide lunch. You can go out and educate people how to recycle and compost. This is getting further into what we would call a recycling crisis. I would suggest people go to the Ocean County website for the recycling department. There is a form that can be easily sent in online for the class.

ASAY: continuing my light up the borough campaign. We got the light working on the boardwalk, and the Central Ave dock, in addition to the soccer fields and bulletin board. The light is now on at Long Point. Camp Meeting seems to be the only public space without light on it now. Jon and I have been working on this for a few months, spoke with our CFO regarding the courts. He states there are funds in the Capital fund but operational funds. We currently have about \$16,000 in Public Works left for the rest of the year. This is my first crack at a proposal to remove and scrap existing scrapping. Using compressed air, remove debris from cracks and seal the area. Twelve foot Netting will be placed around. I've never seen a reason to secure the tennis courts and therefore the net should be fine. We estimate \$25,000 with Public Works doing the bulk of the work.

The CFO recommended a multi-use bond that if money is not used, can be cancelled.

The Municipal Clerk stated that if advertising is to be used on this location, the Borough would have to draft a bid for concession.

The CFO had one additional question as to the 5% down, and whether you are going to raise the funds in future budgets or go out to bond.

Asay: I would fully fund it as it doesn't make sense going the other route.

CFO: you would need some money still to pay for the DOT grant.

GABRIEL: Fire Dept received a nice grant for new airpacks and backup cylinders. This is one of our Capital expenses in our ten-year plan that now is paid for.

CP BERGLUND: Cozy Cove pipe, the new hydrant tried to tie into the current piping by getting the sleeve and run a new pipe at the end of the sleeve. When we clamped it down, there wasn't enough to clamp and it blew out. We found a device that sleeve and supports, and we were able to hold pressure; we solved that issue. If we haven't been able to, then we would've excavated all the way back to the main by Nelson's Creek. Something for the Council to consider with the ordinance being water and sewer. The council chose to do all water this time, but we may be forced to handle sewer. The monthly status on the revaluation, we've cleared a little over 70% of all properties inspected. We are essentially dont which means 30% haven't responded or allowed us into the home.

The Municipal Clerk confirmed with Councilman Gabriel that those who refused to allow the Assessor in to inspect will be unable to appeal taxes.

Mayor Silver stated that Tamara Hall is working to obtain Silver Certification with Sustainable Jersey. He further stated that with the change in UCC, there are tips for homeowners that should provided at the Zoning Department; always call before you dig. A % is needed for all rentals in the Borough, house numbers should be visible. Bill Richert will still be our Fire Official.

Jim Jablonski (227 Ocean Ave): Does the Borough receive the fee?

The Municipal Clerk stated that the Borough receives 10% of the yearly dividends. The checks are made out to Toms River Township.

The Camp Meeting Ground bluff was done as an emergency basis, which cut out the emergency permitted. However, this still has to be closed out. Part of the closing out was planting plants so that the gabions that are filled with stone would have vegetation. The plantings are intended and accepted by the DEP to overflow the gabion and return the area to its historical significance. We now have been released from that project.

COUNCIL REPORTS:

Mr. Asay reported that he has been speaking to Lynn Pendleton regarding the lighting at the Camp Meeting Pavilion and they are going to replace the flood lights and install a similar area light to that which is at Long Point, it will be LED lighting. Ms. Pendleton is also going to use funds raised to install subtle LED lights in the Pavilion which should complete the electric work at this site.

Mr. Asay also reported that Public Works were able to fix a large percentage of the meters that they were having issues getting readings from and that they also did shut offs for non-payments of water/sewer bills to assist with the deficit in the water funds. Mr. Asay also stated that because we have to base the budget off of the previous year that this creates an issue if one year it's dry and the next it is rainy which reflects in the billing. Mr. Asay said it would be better if we could take a 3 year average.

Mr. Gabriel stated that he has been receiving complaints about AIRBNB's in town. Discussion was held on the requirements of CO's and whether we can institute a fee that the company would collect and give to the Borough. The Mayor and Council asked Attorney O'Connell to create an ordinance to impose a tax as the law allows for AIRBNB's. Mr. Doyle from the audience said there are at least 8 listed on the website.

Mr. Berglund reported that the re-evaluation is continuing to be refined and one interesting fact was that commercial properties are required to submit data to the Assessor on income, etc and that information is part of the calculation used to determine the assessments. Mr. Asay asked if there would be a final report to the Council on the overall assessments and Mr. Berglund said he will look into it.

Mr. Berglund stated that the company that supplies the chemicals for the water treatment plant made the recommendation, since we have discoloration and other water issues, to utilize polymer which will help reverse the process our water supply has went through. The polymer should put a coating on pipes and help reduce the number of complaints and have cleaner water. Initially a drum of polymer will be used to in a sense shock the system and if the results are positive it will be reduced and incorporated into the system in a slower manner on a daily basis. The drum was delivered and once Public Works puts the pump in the injection will start.

Ms. Wudzki stated that the IHPTO Trunk or Treat will be Oct. 27th from 1pm-2:30 and all residents and businesses are invited to participate. Also the 6th grade spaghetti dinner is now going to be November 27th as the IH Grade School is closing all week long the week of election.

Ms. Wudzki also reported the IH Fire Department Trucktoberfest is this Saturday from 11am-6pm with a rain date of Sunday October 14th.

Ms. Thompson reported that the IH Board of Education meeting is October 10th at 6:30pm and the Central Regional Board of Education meeting is October 18th at 7pm. Ms. Thompson asked if any results occurred regarding the issues raised by Mr. Wilber at the last meeting. Discussion was held on the interpretative issue and Ms. Wudzki stated she spoke to Mr. Wilber and will be looking into this

and will have a report for the next meeting. Mr. Doyle from 19 Jaynes asked who decides what is paid and Mayor Silver said himself, the CFO and council liaison.

Ms. Snow stated that the Halloween Parade is Oct. 27th at 11am and the bonfire will be that same day at 6:30pm-8pm. Ms. Snow also reported that there is a link for the website; Recycle Coach provided by the NJDEP however it would need Mayor and Council approval to be placed on our website. Ms. Snow said you can see an example on the Ocean County Solid Waste Management website and that there is also an app that can be put phones. It is very informative and useful to help answer questions and where and how to recycle in a specific town.

Mayor Silver reported that the IH Post Office project of converting from oil to natural gas has been completed as the new natural gas heater was installed.

BE IT FURTHER RESOLVED the Donated Leave shall be authorized to be implemented immediately for all eligible employees under the Donated Leave Guideline.

SCHEDULE A DONATED LEAVE GUIDELINES

I. Purpose

- A. The intent of this program is to permit full time, sworn, Island Heights Police

 Department employees to donate earned sick time and/or vacation time on a voluntary basis to another full time, sworn, Island Heights Police Department employee who is suffering from a catastrophic health condition or injury and/or prolonged illness or injury which compels their prolonged absence from work.
- B. An employee who is to be a recipient of donated time must first exhaust all of his/her own accumulated sick, vacation, personal and compensatory time. The employee must also produce a doctor's certification at the onset of the illness or injury to substantiate the nature of the illness or injury, and to specify the length of time that the employee will probably be absent from work. An employee who utilizes donated leave time will be treated as a Borough employee on a leave of absence with pay and will not be subject to a diminishment of wages and benefits.
- C. The donation of sick, personal, compensatory and/or vacation time must be initiated by the employee through the <u>Department Head and/or Council Liaison</u>. The request must be on the forms provided by the Borough and must be made prior to the exhaustion of all accumulated sick, vacation, personal and compensatory time. Upon approval by the Recipient/Donor Committee members, all police department employees, as described above are eligible to donate time on a voluntary basis.

II. Eligibility

A. Recipient

An Island Heights-employee shall be eligible to receive donated sick, personal, compensatory and/or vacation leave from other employees if the employee meets all the following criteria:

- Must have completed one-year continuous service with the Borough of Island Heights.
- Must be suffering from a catastrophic health condition or injury and/or prolonged illness or injury that necessitates the employee's prolonged absence from work for which the employee has no availability of paid leave.

- 3. Must produce acceptable medical verification from a physician or other licensed health care provider. The medical verification must indicate the nature, severity and anticipated duration of the disability resulting from the serious or prolonged health condition or injury involved.
- 4. Exhausted all accrued paid leave time including compensatory time, sick leave, personal and vacation.

B. Donor

An employee to be eligible to donate to another employee must meet the following criteria:

- 1. Must donate whole days
- Must have at least 15 days of accrued sick leave remaining to his/her credit following any donation.
- 3. Must not have solicited no accepted anything of value for donation.

III. Recipient/Donor Committee

- A. A Recipient/Donor Committee shall review every request for donated sick leave. The Recipient/Donor Committee members must approve, by majority, the eligibility of any employee before he/she can participate in the program. Decisions and approvals regarding eligibility will be made on a case-by case basis. The committee shall consist of the following personnel:
 - 1.
 - 2.
 - 3.
 - 4.
- B. An appeals process, through the grievance procedure, shall be available to any requestor who disagrees with the committee's decision.

IV. Procedures

- A. Any employee may request to participate as a recipient in this program by contacting the Department Head or Council Liaison. The Department Head or Council Liaison will require medical documentation concerning the nature, severity and anticipated duration of the medical emergency involved. The Department Head or Council Liaison shall document the request, on forms provided by the Borough, and then shall arrange for a meeting of the Recipient/Donor Committee without delay.
- B. If approved by the Recipient/Donor Committee, the Department Head or Council Liaison will then post on employee bulletin boards or communicate by other appropriate means,

- the name(s) of eligible employee(s) who will have exhausted all earned paid leave time by a designated date. The posting will be done only with the recipients consent. If the employee is unable to consent, the employee's family may consent on behalf of the employee. Notice shall be provided to all appropriate majority representatives.
- C. Full time, sworn employees may donate within the prescribed limitation only whole days of sick leave, compensatory time, vacation leave, or a combination thereof.
- D. The donor and the recipient (or family representative) will fill out the required forms. No one shall directly or indirectly intimidate, threaten or coerce, or attempt to intimidate or coerce any other employee for the purpose of interfering with any right which such employee may have with respect to contributing, receiving or using unpaid leave under this program. The above shall include promising to confer or conferring any benefit (such as appointment, promotion or compensation). An affidavit to this effect shall be signed by the donor. Any employee who engages in the above prohibited conduct shall be subject to disciplinary action.
- E. The donor's leave time will be reduced by the number of days donated with regard to that donor's respective bank.
- F. Any time donated to the recipient will be kept confidential and not disclosed to the recipient or any other individuals requesting this information. This provision will not include any individuals who facilitate this program.
- G. The eligible recipient's leave time will be credited with the donated time indicating the donor may receive days from more than one donor. Records shall be maintained by The Borough's Personnel Office showing the donor's name, number and type of days donated.
- H. The eligible recipient may receive 180 donated days from the date the recipient (employee) exhausts all available accrued sick, vacation, personal and compensatory time.
- Nothing in this policy eliminates the ability of the employee requesting donated leave to request additional paid leave from Borough Council.
- J. If the employees prolonged absence extends beyond the expiration of the 180 day donated leave time, the employee may make application for an additional 80 days to a maximum 260 days donated leave time.
- K. Should an employee return to work, or otherwise terminate the use of leave with donated time remaining, that time will be returned to the donor(s) on a prorated basis in days. Any pro-ration that would amount to less than one day per donor will be rounded up to one day per donor.
- L. The recipient employee, while using donated leave, will continue to earn sick, personal, compensatory and/or vacation leave. If the earned sick leave is unused when the

- employee returns to work, all such earned time shall be retained by the recipient employee and credited to the employee's accrued sick time leave.
- M. If the recipient retires, he/she will not be granted supplemental compensation for any unused sick days, which he/she received through the donated sick leave program.
- N. Once the sick and/or vacation leave has been donated, it may not be revoked by the donor.
- O. Donations may not be used on a retroactive basis
