WHEREAS, to be eligible for this funding the municipality of the Borough of Island Heights shall provide at least 10% of the costs associated with the initial inventory and preliminary mapping; and

WHEREAS, to be eligible for this funding the municipality of the Borough of Island Heights shall comply with N.J.C.A. 7:22A, specifically the Department's standards for preparing the initial inventory and preliminary map, N.J.A.C. 7:22A-3.

NOW, THEREFORE BE IT RESOLVED, by the governing body of the municipality of the Borough of Island Heights: that Mayor David M. Any payroll deductions for tire were The Mayor said he believed a not approved by the council. situation was gotten into that the stops couldn't be pulled out of. Mr. Gabriel stated that he hoped all the information discussed during Closed Session stays here. Mr. Stocco said he had heard that this practice was taking place at which time he confronted the Mayor and Mr. Gabriel who stated they had no knowledge of this practice. Mr. Skinner said that the Governing Body should take a look at the policies and this situation, and if the tires are going on a private vehicle it is a violation of the law. Mr. Skinner asked that the Borough Attorney review the transaction on a whole.

Mr. Skinner discussed the current employees who are receiving 1099's, this includes the Public Assistance Director, Building Inspector and Animal Control. Mr. Gabriel stated that he had been receiving his salary this way for 24 years, that legal opinion had been given that he was hired as a professional service. Also the Animal Control Officer's agreement should be reviewed. Mr. Skinner also recommended per attached that a ruling on the pension deductions on certain employees who hold dual offices be ruled on by N.J. Division of Pensions.

Mr. Skinner also said if not the borough does not already have in place, a Resolution should be adopted prior to budget adoption the exact salaries percentage that will be charged to the various appropriations. He also noted that currently the police salaries are approximately 70% spent as of July and we are only 58% through the year.

Discussion on the Water Rehabilitation Loan, there was no backup on any of the payments from 03/01/90, there were no sign sheets, Mr. Skinner said someone had to sign off, we don't know what records Bonnie used to pay people. Mr. Hutchinson asked who supervised that job, Mayor Siddons replied Mr. Stocco, kept the records.

Mr. Skinner said that he had reviewed Ordinance 90-02, approving

\$68,000.00, for the purchase of a Utility Truck and Backhoe, the Utility Truck was ordered under NJ State Contract in May, for the total cost of \$21,527.00, bids were received for the Backhoe on August 28, 1990, in the amount of \$32,275.00, the cost of the two vehicles including an estimated, ated \$2,000.00 for Legal Costs and Advertising, provided the facts as we know them there are sufficient funds available in this ordinance to award the contract for the purchase of the backhoe.

Mr. Skinner said he will have to review Ordinance 90-05 for the renovations of the municipal complex buildings.

Mr. Hutchinson said there is one other problem the borough is due to have a Note Roll Over on the 12th of October, the problem with Mr. Grigg asked if we could who will sign the documents required. hire a municipal accountant, Mr. Skinner agreed for what we needed and April could get the posting up to date. Mr. Gabriel said the borough is faced with a very serious situation and something has to be done. Mr. Grigg suggested that an accounting firm be contacted, with either the appointment of a firm or an individual from the Mr. Skinner stated the Borough could pass an Emergency Resolution to Appropriate funds for this expenditure. Discussion on why this information was held for closed session, Mayor Siddons said that personnel is involved, to include the possibility of malfeasance in office, if this was discussed in opened session the borough could also be liable for any statements made.




