Mr. Adams suggested that the Mayor & Council consider laying off two officers, and enter into an agreement with Dover Township for Mr. Corrigan stated that the Patrolman are the mid-night shift. basing they unfair labor practice stating that the borough refused to negotiate with the police department as a separate entity, and the police had been grouped with non-police employees. the agreement was never reduced to writing. The ordinances were adopted and the employees have been receiving the benefits provided for in those ordinances. Mr. Dempsey said that the patrolmen are willing to take 10% this year and 10% next year. We can split this rate each year. The going rate is 6>5 % - 7% range. He would like to have authorization to offer 7% for each year of the agreement. Mr. Corrigan would like to settle the unfair labor practice suit without going to PERC, it appears that as in all small towns they are underpaid in the eyes of an arbitrator. Mayor Siddons said that they could eliminate an employee for economic reasons. Corrigan asked the council if the could afford a police department that would receive a 7% increase? Mrs. Bottomley stated that the salary and the decision of cutting the force are two separate issues. Mayor Siddons said that the 1991 budget was prepares with no increase in salary and the layoff of one patrolman. Mrs. Cullen asked about cuts in other departments. Mayor Siddons, asked where else can we cut? We are down to the bone now. The additional problems with the police department is the fact that they will be new vehicles as well as maintaining the old ones, which expenses are now within the CAP. Mayor Siddons said that Borough has received a letter from M. White, stating that he was no longer part of the bargaining unit. Mr. Corrigan said, Mr. White is still part of the unit the only way would be if he acted in a supervisory Mr. Corrigan expressed a belief that a settlement could be reached without ending up in arbitration. Mrs. Cullen said she would like to depend on a CAP Waiver because all the employees are grossly underpaid. Mayor siddons said by the police looking or a higher than 5%increase they will be faced with loosing more employees, all the other departments are being treated equal and not faced with loosing employees.

Discussion from Mr. Stocco about the rental of the boat slip, per the Borough Attorney these will have to go to public auction, the proper resolutions will be prepared for the meeting of the 10th.



Mayor Siddons turned this portion to Mrs. Cullen who stated that in the meetings with Mr. Corrigan, the estimated cost arbitrator would be approx. \$800.00, Mr. Corrigan's fees approx. \$1,600.00, and the police are still looking for the 10% increase. Mrs. Cullen stated she feels the Chief should be asked to resign. Mrs. Bottomley said she would like to have council's permission to make a good faith offering of 8% for 1991 and 9% for 1992, this doesn't mean we have to keep the department. Mr. Gabriel said that the problem with the department is the lack of leadership.. Grigg said that the 1991 budget is still not settled, Mr. Stocco asked about the rest of the employees, Mayor Siddons said they will be able to retain their jobs. Discission continued, Mr. Gabriel asked the attorney once again about the tire expenditure in which the police chief was involved with. Mr. Gabriel also asked if any member of council had given the authorization for anyone to purchase gasoline for a private vehicle. Mayor Siddons noted that the police department is running with six men and if this continues there will be an overrun again. The Council will have to make a decision to terminate one. The Borough Attorney stated that this would have to be done by resolution for economy reasons. discussion on the number of men working a shift, Mr. Grigg said that they have tried to tell the chief but they cannot interfere with the day to day operations of the police department. Borough Attorney said that specific incidents have to be documented and letters of reprimand sent. The position can be abolished for financial reasons.. Mr,. Grigg said that time should be taken, contracts should be settled with the patrolman first, then a reduction in the rank of the department. Mayor Siddons asked that Grigg speak to the Chief so the patrolman who will be considered for the lay off will have notice prior to reading it in the newspaper.

Mayor Siddons notice the council on the resignation of Tax Clerk, Maryann Fruend, Wendy Prior will be picking up the additional hours.

Closed session adjourned at 8:50 P.M., motion by Mr. Gabriel second by Mr. Grigg, voice favor, all in favor.

As a result Bob Burger would be demoted to the rank of Police Sergeant, it would not effect his salary, and he is a senior employee and can't be laid Mr. Hutchinson said he has discussed this with the Police Committee and the Mayor, in his opinion the Borough can do it, there is some dispute and he suspects that there will be litigation over it. Chief Burger has mentioned to Mr. Hutchinson that he has spoken with his attorney and there is some question in the law. Mr. Hutchinson stated that his opinion is that you can do this. The borough should be aware of the mechanics, to hire a Public Safety Director the borough is going to have to pay a salary, the abolishment of the position of the Chief of Police can't be done as a disciplinary action, the Chief of Police has tenure. In order for him to be disciplined or lose his office, he is entitled to a hearing. This procedure is for economic policy that would eliminate the position, and not a reflection on his performance of his duties a Chief of Police. It is important to remember that because it that's found to be the case, then this ordinance can be thrown out, it is significant that the council be aware of this. The borough will have to come up with money to paid for this public safety director, in talking to the Mayor it is the plan to leave all the remaining officers we have on so all the shifts would be covered. The economic theory is that by having Bob now as a Sergeant, you'll have more patrol hours and the administrative duties won't need a full time employee, that is the economic instification. Mr. Hutchinson said that he notified Chief Burger justification. Mr. Hutchinson said that he notified Chief Burger that the governing body would be discussing this subject this evening, and since it effects the terms of his employment he is entitled to be heard. In summation the borough can do this but entitled to be heard. In summation the borough can do this but there will be a dispute, an as a matter of policy there is going to be mechanics that will have to be worked out. Mr. Hutchinson said he had discussed with Mr. Goldberg the vacuum period, Mr. Hutchinson recommended that this not be adopted until the borough has someone to fill the position of Public Safety Director, or you have a department without leadership. Mr. Stocco asked if they were statutory provisions for the person who would be in charge of the department? Mr. Hutchinson said there is no statute that says you must have a Police Chief, but you do because someone has to run the department. Mayor Siddons asked would not the Police sargent act in the behalf of the Public Safety Director. Mr. Hutchinson said the present ordinance provides that in the event of the absence of the Chief of Police, that the Sergeant would act as

The only problem here supposing thi Chief in his absence. amendment is adopted you no longer have a Chief of Police. You can argue that the sergeant can act in place of the Public Safety Director. Mr. Hutchinson stated that this amendment does is changes those provisions which creates the position of Chief of Police and provides the Chief of Police's responsibilities and duties, anywhere in the ordinance that refers to the chief of police has been eliminated. Mr. Stocco asked if then the sergeant can distrate the policy and the convertions of the department? police has been eliminated. Mr. Stocco asked if then the sergeant can dictate the policy and the operations of the department? Mr. Hutchinson said in the absence of a higher authority. The intend is if the Chief or Public Safety Director is on vacation the sergeant can then fill in. Mr. Hutchinson said his recommendation is that the borough have a public safety director in line before this amendment is adopted. Mr. Goldberg said that we are just looking at first reading this evening, and Chief would remain so uptil second reading. Mr. Hutchinson said in discussion with Mr. until second reading. Mr. Hutchinson said in discussion with Mr. Goldberg the Borough could hold off on the second reading until the borough has a Public Safety Director lined up. Mr. Stocco noted that there would have to be guidelines set up for that position as well. Mayor Siddons asked if Mr. Goldberg had any additional information, Mr. Goldberg stated that the Chief has indicated that 80% of his job duties are administrative and that for a borough of this size we can't afford a Chief that spends 80% of his administrating. Mr. Goldberg said he feels we could get more bang out of our dollars if the Chief were patrolling and we had a part time administrator, the police salaries perhaps would go down. This is a purely economical move and the citizens will benefit Chief Burger asked if he were to patrol on a 5 day basis you woul not need this ordinance, Mr. Goldberg stated that he didn't sa that either. Chief Burger said that would be the fact whether i was economical or not. Mr. Goldberg said that Chief had indicated the fair 80% labor ຍLandards that ο£ his iob administrative, Chief Burger said that can be rescinded, it is the Chief's options, he also stated he would like to see where this is coming from. Mr. Goldberg said that is one aspect of his concern, if we didn't have a Chief I think the council would have more control over the department, I think this is a policy move. Mr. Goldberg stated again that he thought this was a policy move. We could have more control over a civilian administrator, there ar economic concerns, Mr. Goldberg asked the borough attorney for his opinion and he concurred. Chief Burger said it was his opinion and he concurred. Chief Burger said it was his understanding that the only legal change that could be made and he did discuss this with Mr. Hutchinson would be for an economic reason, and it seems now it has become a policy political movement rather than an economic one. Mr. Goldberg stated that he did not state that, I didn't us the word political, Chief Burger noted that Mr. Goldberg said that the governing body would have more control over the police department. Mr. Goldberg said that the primary concern was economics, but there are other concerns as well. Mr. Stocco, asked Chief Burger about his discussion with various attorney's regarding the aforementioned matter. Chief Burger stated that there are several case laws, and it really comes down to fine line policy and the reason why it's done. It can be done legally if it's a new department, NJ is currently in the process of

eliminating Public Safety Directors, an example is Bricktown, where they just hired a Chief to replace a Public Safety Director. reason is that the Chief has many powers which a Public Safety Director does not. Mr. Ryan concurred that a Chief does have some authority that a Director does not. The goal of the police departments is to get as far away from the politics, it seems with a public safety director, it just draws you closer. This is why the Chief's have tenure, you're paid to up hold the law and treat everybody fairly. Mr. Stocco asked Mr. Hutchinson if he was familiar with any of the cases, Mr. Hutchinson referred to one case that deals with this issue. Chief Burger noted that you can't have a director running the department interfering with the day to day operations. Mr. Goldberg asked Chief Burger is he thought the council was interfering when they request he appear, Chief Burger stated no he did not. Mr. Goldberg asked Mr. Hutchinson if the governing body had the authority to eliminate the position of Police Chief, Mr. Hutchinson said they have the authority to eliminated the position of Chief provided it's for justifiable reasons (ex. not for a disciplinary action or not for a political reason) economics and broad policy. Mr. Goldberg said that he had used the word policy, because this is what had been discussed. Mr. Ryan said he believed Mr. Hutchinson had spoken with Mr. Goldberg and that there had been research done, Mr. Hutchinson noted what happened in Jackson was that the Chief retired and then they appointed a Director. Mr. Goldberg asked Mr. Hutchinson if in fact the governing body had the power to eliminate the entire department, and enter into a interlocal agreement, and then our obligations would end for these men, and the Chief would then be unemployed. Mr. Stocco asked if the salary for the Chief if this should be adopted remain the same, Mr. Hutchinson concurred. Chief Burger said if this is strictly for economics, he would accept the terms to rectify this, and remain in the post, he would be more than willing to take a shift. Mr. Goldberg said he thought the borough would get more for the dollar if we have Chief Burger a Sergeant, it's an economic decision. Chief Burger asked how that was arrived at. Mr. Goldberg said you would then be patrolling 5 days a week, Chief Burger said he just agreed to do that. Mr. Goldberg said he would prefer to see Chief as Sergeant Burger because economically he would prefer that. Mr. Hutchinson said in fairness to Chief Burger, as Chief Burger you couldn't be required to patrol 5 days a week and that is a consideration, it is a valid point and an argument that will be made. Mr. Ryan asked if that request had been made of the Chief to patrol a specific number of shifts. Chief Burger said does it end when the make me sergeant, they will still have to pay a director, I can't think that anyone would do it for less than his salary, Is. Hts. Chief is the lowest paid Chief in the state, if anyone has any back ground or experience he is going to demand salary. Mr. Goldberg said that maybe we could get a part-timer.

Chief Burger said he didn't know if the position could be filled by a part-time employee, Mr. Goldberg asked the question of Mr. Hutchinson, who responded he didn't see why not. Mr. Ryan stated all this would be spelled out in the boundaries of his contract. Chief Burger said it would cost more money to reduce me to sergeant

and hire a director then to put me back on the road. If that what you're looking for then say it, but not that you're saving money. Mr. Goldberg stated that Mr. Hutchinson summarized it best, when he said as a sergeant you would patrol, and as a Chief the council has no authority, Chief Burger stated that it is stated that he as Chief can decide his work hours, and a contractual agreement would be find. He sees a real battle in the making. Mr. Goldberg stated that the council and the borough should not be intimidated by a battle, Chief Burger said I think anyone here would fight for their job, I've served this town for 15 years. Mr. Goldberg noted that the council has the authority to make Chief Burger a sergeant, to eliminate the position of Chief, he doesn't think the council should be intimidated by the fact that litigation might come out of this, it is clear that litigation will come out of it. And if litigation does come out of it, I think it will be money well spent. Mr. Hutchinson said the basic Ordinance adopting the SOP's for the Police Department is advertised for final adoption this evening, the council can adopt tonight. Then the ordinance abolishing the position of the chief can be introduced and voted on. Mayor Siddons explained the order of business to take place in open session.

Mr. Goldberg had additional business, he had received a letter from Joe Indiero, reference to Crossing Guard. Chief Burger said that a Crossing Guard had been appointed by the council, Mr Indiero had been insistent on coming back. Mr. Goldberg asked if we were bound by the contract, discussion between the Mayor and Mr. Goldberg as to this position, Mayor Siddons stated that the recommendation hire her had come from the Chief. Mayor Siddons said that at the Police Committee meeting he didn't know if she had been hired. The Borough Clerk noted that the person in question had been hired as Beach Badge Checker/Crossing Guard. Mr. Stocco said this was not fair to her as school is scheduled to start in a few days. Mr. Hutchinson said she is not a permanent employee. Mr. Gabriel suggested that Mr. Indero do the Church Crossing on Sunday's, Municipal Court and be the substitute Crossing Guard. Mr. Goldberg asked if this woman is well liked around town, he asked the Clerk if she had gotten any comments from the residents, the Clerk responded that there have been no formal written complaints. Mr. Ryan asked if we were locked into, Mr. Goldberg said he was going to make a formal motion.

Motion to adjourn closed session at 9:50 p.m.by Mr. Stocco, second by Mr. Ryan, voice vote, all in favor.

Regular Meeting

Closed Session 8:30 P.M.

Mayor Siddons called to the closed session to order, for the record the following were present; Mr. Gabriel, Mrs. Bottomley, Mr. Goldberg, Mrs. Kaplowitz, Mr. Ryan Borough Attorney Hutchinson and the Borough Clerk. Mr. Stocco was absent.

Mr. Goldberg stated that at the meeting of the Police Committee held on October 15, the following unanimous recommendation. Police Committee had received a letter from the Ocean County Prosecutor's Office. (letter on file). The Police Committee felt strongly that this matter should be referred to the Attorney General's Office in connection with the letter from the Prosecutor. The letter was unsolicited, Mr. Goldberg stated that he felt that the Prosecutor had over stepped his bounds, and usurped his Mr. Goldberg stated that the thrust he was to intimidate this governing body, he also noted that regardless what this governing body does, it is not the business of the Ocean County Prosecutor, and the matter should be referred to the Chief Law Enforcement Office of the state for a review of the prosecutors Mr. Goldberg stated that the internal affairs of this town should remain just that. Mayor Siddons noted that this is way out of line for him, for him to get into this he had to be way out of line, the Mayor also reminded everyone that this has to remain in closed session. Mrs. Bottomley suggested that just a cover letter be send and let the Attorney General respond, Mr. Goldberg asked that the Borough Attorney prepare the letter to the Attorney Mr. Hutchinson advised that council that practically speaking nothing will happen. Mr. Ryan said this will eliminate him doing it again and interfering in our affairs.

Mayor Siddons said that the next problem upsets him, he has the feeling that someone is misusing their legal office for the purpose of getting business. The Chief wrote a letter of reprimand, the 22nd of June to Ptl. Barstow, Ptl Barstow then had his attorney Karl Mohl wrote back to the chief threatening the Chief. Siddons read from the letter. The next time we find Mr. Mohl he is representing the Chief, the Mayor noted that he finds this a complete conflict of interest. He also said that Mr. Mohl should be taken to the ethics committee in this county and be nailed for this. We don't have any idea if that letter of reprimand is still in Ptl. Barstow's file, the Mayor said the issue should go to the ethics committee, he can't represent management and labor, it has to be totally unethical. The correspondence came in on July 1, and he is still representing the Chief, there has to be some ethics. Mrs. Bottomley asked what letter had he written on behalf of the Chief, Mr. Hutchinson referred back to when the borough was considering the ordinance. He also contacted the attorney when the resolution setting the chief's hours was adopted. The Mayor said we have the letters. Mr. Goldberg stated the on one hand he is asking the Chief to put a letter from a disciplinary file and on

the other he is representing the chief. Mr. Goldberg said he did not know if he had violated the cannon of ethics. Mr. Hutchinson said he had discussed this with the Mayor and it is a conflict but Clients can waive a is the borough involved n the conflict. conflict, the Mayor said we recommend that the Chief take what ever action that was necessary. Mr. Goldberg said we still don't know if the letter is still in the file, and if it's not then there is a definite conflict of interest, and someone should be looking into Mayor Siddons asked that all correspondence be forwarded to the ethics committee and ask them to investigate. Mr. Hutchinson said this should not be discussed in public. Mrs. Bottomley asked do we have another option, the attorney said you could send him a letter and ask him not represent the chief. Mrs. Bottomley asked what are you most mad about that he did it or do you want him never to do it again, or do you want to hurt him. Mayor Siddons said he we don't have to crucify him, but it should go to his piers, and he should be slapped on the knuckles for it. Mr. Goldberg stated that it was his opinion that if the borough contact Mr. Mohl directly he would not acknowledge a conflict. Mrs. Bottomley stated that we ought to give him the option. Mayor Siddons said he given the option, he will build up the whole thing, if it is submitted in mass and we asked for it to be investigated it's totally done, and we have not taken any action, other than transmitting his letters to someone else. The same as the Prosecutor, we transmitted his letter. Mr. Mohl is obviously not going to get drummed out of the trade for this, but he will be told he can't handle two people and his knuckles will be severely slapped by his piers. The borough is not in the position of questioning or telling him that he is n conflict because we are not attorney's. Mr. Hutchinson said it looks like a conflict, but his gut feeling is he doesn't want to do Mayor Siddons said if that letter is not in the file, then what are we going to do, that's pushing the issue beyond credibility. Mr. Gabriel suggested that we find out if the letter is in the file. Mr. Goldberg stated that he didn't want to hurt anyone either, but as an attorney, he thinks it should be referred there. Mayor Siddons asked how do we find out if the letter is Mr. Hutchinson said he would contact the still in the file? Chief, the Mayor asked how can you find out if it is removed or not? Mr. Ryan said if that has been removed it smacks of a little conspiracy, then you have another problem. Mr. Goldberg noted if it's not in the file then you have a bigger problem. Mayor Siddons said we have a problem but is it legally there. Mr. Hutchinson said we are still entitled to know. Mrs. Bottomley said just send the whole thing, and not get involved, just send it off, and then some one find out it's not there. Mr. Goldberg said he would like to be polled on this he agreed that it should be done, all other members polled with the exception of Mr. Gabriel when polled concurred with Mr. Goldberg. Mrs. Bottomley suggested that Mr. Hutchinson find gentle words. Mayor Siddons noted that we don't want to kill the guy, Mr. Ryan stated that we want to put a little harness on him, to quit interfering in our affairs, that was the feeling of the police committee that there are too many people outside this township becoming involved in the running of this department, and we don't need the interference.

Mr. Gabriel said one more thing, the Mayor should be authorized to meet with Dover Township and negotiate for an Animal Control Officer. We are going to have some one get bit and then we are going to have a problem, all we need is one child bitten. Mr. Ryan sid we are continually receiving complaints about the crossing quard, Mr. Goldberg said he had received a letter from Alice Meyer, he wrote the Chief asking him to provide him with a copy of the police report and look into the matter. Mr. Goldberg noted that she was not very helpful or nice and looked the other way wasn't relaying what she knew. The letter was referred to the Chief, Mr. Ryan asked if the Crossing Guard had tenure, Mr. Hutchinson responded none. Can we just eliminate her, Mr. Hutchinson said she still has her rights under the Open Public Meetings Act, if he position is going to be discussed about termination of her employment in closed session she has to be notified. Mrs. Bottomley Mayor Siddons said all she has heard was at the public meeting. said he had other complaints from parents, the kids do not relate to her at all. Mrs. Bottomley said unless it's in writing. Mrs. Kapowitz said if she is a Crossing Guard, what else is she liable for, Mayor Siddons said in the case of an emergency she should attempt to get someone there. The complaint went to the chief and we're waiting for a response.

Motion to adjourn at 8:55 p.m., made by Mr. Gabriel second Mr. Goldberg, voice vote, all in favor.

Mayor Siddons explained that the police have agreed to settle for a 7% increase in 1991, 6% increase in 1992, and for 1993 to take whatever the cap is. Mayor Siddons informed council that the same offer was made to the employees through Mr. Price and hopefully a response would be forthcoming for the next meeting.
