For the record the following were present; Mrs. Bottomley, Mrs. Chambers, Mr. Goldberg, Mr. McKelvey, Mr. Ryan, Mr. Warfield, Borough Attorney, Acting Chief White, Borough Treasurer and Borough Clerk.

Mayor Siddons called the session to order.

Mayor Siddons referred to agenda item #4, approval of vacation time carry over, a consensus was to go along with the carry over for the employees involved. Mayor Siddons asked for comments from council. Mr. Warfield resented that this has occurred, and he is against this, Mr. Goldberg concurred. The Borough Clerk noted that the Mayor had been advised of this situation prior to December, at that time he assured the employees effected they would not loose the days.

Mayor Siddons referred payment of sick leave pursuant to the Employees Contract, the contract says after 100 days of accrued sick, additional days would be paid for. He asked for Mr. Mutter to advise so that payment could be made after the next meeting.

Mrs. Bottomley set a Grievance Procedure Meeting for January 13th, 4:00 p.m., with Mr. Ryan and Mr. Warfield.

Mr. Goldberg asked about the Karl Mohel ethic complaint, Mr. Mutter has heard nothing to date. Mr. Mutter read the withdrawal letter from Mr. Mohel from representation of various members of the police department in the case of DiSanti v Borough.

Mr. McKelvey met with Bonding Company, copy of punch list provided to all members.

Mr. Mutter for the record the next item is the continuing investigation into the conduct of Chief Burger. On December 22, 1992, in executive session the governing body authorized Mr. Mutter to obtain the services of a Special Hearing Prosecutor, which is Mr. Coronato of Mulvaney, Coronato and Brady. To have him file section 147 complaint with civil charges against the Chief, to be done by January 01, 1993, with a hearing date of January 11, 1993. The record indicates that this has been done.

Mr. Coronato is present to give a presentation regarding his position as hearing prosecutor. Mr. Coronato said we his recommendation is that the Borough not consider any other adjournments, unless he comes back with from Deborah or a heart specialist, who gives us in detail what the problem is.

Mr. Coronato said he is entitled to one adjournment, without any conditions. One of the problems with the case is the matter still pending before the Prosecutor's Office. We have not been advised as to what their recommendations will be. If the decision is made to have the hearing and the Prosecutor's Office has not made a

determination, any statement made at a hearing here may be used in a criminal case. Mayor Siddons said we can still take administrative action.

Mr. Coronato said he could be suspended for not going to the borough's physician, but he does not recommend this action being taken, he suggested that the council hold off on this.

Mr. Coronato said the goal is not to have him as the Police Chief, and the second goal is that it not cost the town any money. In discussions with Mr. Mohel, it was indicated that Burger would no longer be the Chief, and his client did have a major heart problem. If he could prove a heart problem he could apply for a disability through the state pension bureau.

Mr. Coronato said he is charges with numerous items, and the burden is not with the council but with a Superior Court Judge, at that hearing he can amend any evidence that is presented to Mayor and Council.

Mr. Coronato he recommended that we wait for a determination from the Prosecutor's Office. Mr. Ryan said the best case is that he arbitrarily issued gun permits to non-residents. Mr. Coronato said he knows at of least three other chief's who have done the same thing. Mr. Coronato said the ultimate goal is that he is no longer employed by the town, and it doesn't cost the town any money. Mr. Ryan said he would like to see him discharged from the office. Mr. Coronato said he didn't believe that the Prosecutor's Office would indite him. He had two pints; a) do not want him as you're police chief, b) as a law enforcement office in the borough, c) no charge to the budget.

Mr. Ryan said he agreed if we have to go to court, we felt there was a crime committed, and everyone wanted to bring him here for an administrative hearing.

Mr. Coronato asked that no public comments be made. Mr. Goldberg stated that Burger has committed a crime, and he is not having this rolled over into a package, that a deal will be cut. And he should be prosecuted to the max. The Mayor agreed but questioned, whether the borough could press criminal charges and if a complaint could be instituted. Mr. Goldberg said if he appeals before a Superior Court Judge, he committed misconduct. The hearing should go forth.

Discussion on the adjournment process, and if he requests another adjournment it would have to be with a doctor's recommendation.

Mrs. Chambers that the complaints against him be reviewed. Mr. Goldberg said that the borough should not make a deal.

Mrs. Bottomley asked why can't we suspend him this evening, he has never produced the proper documentation.

Discussion continued between Mr. Coronato, Mr. Mutter asked if the

borough took his advice and disposed of the pending civil charges with the various options. As part of that package we are not taking a position of the charges being investigated by the Prosecutor's Office, and let them make the call.

Mr. Coronato asked that the council affirm, that the matter be adjourned until the 29th of January. If a further adjournment is requested, the only condition would be for medical reasons. Authorization to continue discussions with Mr. Mohel, all members were in favor with the exception of Mr. Goldberg and Mrs. Chambers.

Motion to adjourn the closed session at 10:30 p.m., made by Mr. Ryan second by Mrs. Bottomley, voice vote, all in favor.

Mr. Mutter went over the procedure for this evening;

1. He has been advised that Mr. Mohel, is aware of this evenings proceedings.

2. This is a follow up to a previous determination that was made by the governing body for a continued discussion by the Special Prosector's.

To discuss an resolution to the matter.

Mr. Brady spoke to the governing body regarding his conversation with the Chief's Attorney, and to bring the governing body up to date on the events. The matter will go forward on the 29th, and that a resignation may occur based on the condition of the Chief. Mr. Brady said in the event the Chief does resign, the issue would be moot, and that would be a mutually acceptable result. Given the information supplied it is his choice either to resign or go through with the hearing. Based on discussion with Mr. Mohel, a resignation should be forth coming.

Mr. Mutter said he spoke to Dr. Vivona's office and an examination is scheduled for Thursday, January 28, 93.

Mr. Coronato said in speaking with Mr. Mohel, his client would be notified to have an examination, as indicated no further adjournments would be granted unless the borough's doctor had made a determination as to his condition.

Mr. Mutter asked that the record indicate, the Payroll Clerk had been authorized to communicate in writing with the Chief, advising failure to submit to a physical examination has failed to confirm your continuing eligibility for sick leave.

Mayor Siddons said we have a problem if he makes the medical appointment and attends the hearing and we're not prepared. Mr. Mutter asked if the hearing is held on Jan. 29th, there is no authority for the discovery demands and none exchanged from Either side. Mr. Brady said this is not a judicial proceeding, the borough is the employer. Whatever is done by the governing body could be appealed and referred to Superior Court, more evidence could be presented at that point, more witness and discovery.

If information is presented that the Chief is to ill for the hearing, the decision will have to be made based on information presented. The recommendation is to keep the pressure on. The best is for him to resign and prove his case to the pension bureau.

Mayor Siddons asked if there was any other information regarding

the hearing. Witness's would be called, and they would be Acting Chief White and the Chief Financial Officer. Mr. Brady said the Chief has the right to be represented by counsel and the right to call witness's. Mr. Mohel has indicated that council would be Mr. Mutter cited a case in a non-judicial context subpoenaed. allowed to make a ruling on the merits. Mr. Mutter asked when is he going to resign, Mr. Coronato said he could come in that night. Mrs. Chambers asked if we had to accept his resignation? Goldberg said maybe we should hold the hearing anyway. Bottomley asked that all information be made to his attorney. Mutter asked if Mr. Mohel was aware that the resignation was unconditional. Mr. Coronato said only if the doctor states that he has a sever heart problem and resigns, under the contract indicates that all benefits are prorated out.

Mr. Goldberg said the entire department is in limbo until the situation is resolved. Mr. Mutter asked that an attempt be made to secure the resignation by Wednesday.

Mr. Coronato said the key is to get him out, and their case may not take long.

Mayor Siddons asked that any discussion be continued with the committee assigned to this matter.

Mr. Goldberg asked the status of the Karl Mohel ethics compliant, Mr. Mutter updated council. He spoke to Mr. Secare who advised that the ethics committee met, this was discussion and they have made a determination and we will receive the determination in writing.

Mayor Siddons made one other announcement, after receiving Mr. Goldberg's memo, he called Judge Serpentelli, who advised, that we use reasonable approach. Mr. Goldberg said it was represented that there was an absolute right to an adjournment, the case does no say that at all.

Mr. Mutter asked if Mr. Marini should be sent a Rice Notice, he updated the situation. Letter was sent regarding an examination by the borough physician, after speaking to the office they have had no contact with him. Rice Notice will be sent for the 29th.

Mr. Mutter said a stop work order had been issued to the Olde Maple Inn, a meeting between the county, Mr. Eak, Mr. Ellis and Mr. Sharniak, Mr. Wright will present an informal application to the

Planning Board. Mayor Siddons asked that the county make sure the building is secure.

Mr. McKelvey mentioned the status of the EOC/Police Bldg., currently reviewing if there is a breech of contract, a meeting will be scheduled.

Motion to adjourn the closed session made by Mrs. Chambers second by Mr. Goldberg.

Mr. Mutter reported that he has been contacted by the Prosecutor's Office for a copy of the minutes from the Administrative Hearing/Chief Burger. The are interested in the testimony regarding the purchase of a machine gun. Discussion if the borough has to surrender that information. Mr. Mutter said they could attempt to subpoena, and that could be quashed.

Mr. Warfield said the borough has 6 properties that the borough could foreclose. Mr. Mutter said fees would include; Title Search, Filing Fees and Legal Fees at \$90.00 per hour. Mr. Warfield suggested that we wait and see.
