MAYOR DOYLE INTRODUCED THE COUNCIL MEMBER REPORTS:

Mayor Doyle – Some areas of the Borough near the water have had issues with rats on their property seeking food and/or shelter. I encourage all of our residents to be vigilant in maintaining your property, speak to your neighbors and work together to be sure that food sources and areas of possible shelter are removed.

I urge everyone to stay informed, sign up for our Borough Newsletter and Email bulletins, check our website and television channel regularly for updates on Borough events and issues. Sign up for the Code Red (reverse 911 system) to stay informed in the event of emergencies.

The Borough received our annual audit report which raised no issues with Borough finances for the fourth year in a row. The report will be published shortly on our website.

Our road paving projects continue with Maple, Garden and Garfield underway and Holly and Lake Drive to start in November.

Work has begun renovating our new First Aid Squad Headquarters along side the Firehouse with occupancy expected by the end of the year.

Our new fire truck has been ordered and delivery is expected in 2026. As you know, we have no fire tax in the Borough which would cost each property owner approximately \$400.00 per year. In lieu of this tax, I urge all of our residents to join my wife and I and make a generous contribution to our Fire Company. Their hard work and dedication keep us safe and their excellent ratings help with our homeowners insurance rates.

Ms. Thompson - The community garden is used by sixty five Island Heights residents. In the summer of 2023, the DPW removed the open compost heap located outside of the community garden fence. This was done out of concerns that rats were living within the compost pile. During the removal a rat ran from the pile and up a garden path. This was the last time a rat was observed in the garden area. Since the summer of 2023, the community gardeners put all garden debris into robocans. The gardeners move the cans to the curb to be emptied weekly and roll them back. For a year and half there have been no sightings of rats in the community garden. Gardeners who visit regularly at various times of day have not seen rats.

The Borough hired an exterminator to inspect the garden and surrounding municipal buildings. No rats were observed in the garden.

Out of an abundance of caution DPW leveled and removed the butterfly/pollinator garden. That garden although a good idea had become overgrown. No rats or rat nests were discovered during or after removal. Several people have commented that the community garden looks better with the pollinator garden removed. The Borough set traps around its municipal buildings. The traps set and monitored by DPW have been in place inside the garden for two weeks. The only things caught in the traps were a bunny, a chipmunk and two squirrels.

All gardeners were directed by the Borough to remove any veggies that may have fallen to the ground and immediately tidy up any overgrowth. The gardeners have complied. The Borough has directed that all plant material must be removed from the garden by the November 15th closing date. That date is stated within the use agreement that every gardener was required to sign. Any plants known to be rodent repellents such as garlic, onion, rosemary and sage can stay. These plants are typically left over winter in a garden for continued growing in the spring. Some of these plants such as garlic are known to be toxic to rats. Should any plant material not be removed by the deadline, volunteers from the garden will be tasked to complete the removal by November 20th. Any remaining material after the 20th will be removed by the DPW. The gardeners have done everything that has been asked of them to deter rats from benefitting from the garden.

There are known conditions that can attract rats to residential properties. These include compost piles which are not contained by robust walls or in cans, vegetable gardens that are not tended, accessible crawl spaces, accessible areas under porches and bird feeders. Our residents need to survey their own properties to eliminate any conditions which might support rats. Residents need to help each other by communicating concerns to each other that may be affecting their neighborhood. The rat problem will be abated with the diligence of everyone affected.

Our Code Enforcement Office reports that 1300 Recreation Badges have been sold to date, 41 Tree Permits Issued, 44 Zoning reviews completed and 38 rental and sale property inspections have been completed.

Our Construction Office reports that over 300 permits have been issued this year with revenue of \$82,000.00 and over 600 inspections completed by our professionals. Permit holders can now request their inspections via the Borough's public portal on the construction page of our website. Also new on the website, a frequently asked questions button has been added to help residents determine whether their project may need a permit or zoning approval.

Our Environmental Committee will meet next on 11/20/24 and all are welcome.

Mr. Fumo – Our Fire Company has responded to 165 calls for service year to date. They have received new radios at no cost to the company from Toms River for both their vehicles and for firefighters to carry with them when in service. The company and the Borough express thanks to Toms River for their generosity in providing this state of the art equipment.

Our First Aid Squad has welcomed two new members and they have responded to over 200 calls for service this year. The Squad has begun work on their new headquarters on Lake Avenue along side of the Firehouse, they hope to occupy the new building by the end of 2024.

There is no evidence of rats living in the community garden space, they usually do not range very far from their birthplace.

Mr. Baxter – Our Municipal Court has no session in October, they will return on November 18th. Our Planning Board had an October meeting; they have no new applications pending.

Ms. Pendleton – With the warm weather our DPW is still mowing and landscaping our public properties. They completed water and sewer connections for several new homes in the Borough. Two pumps had to be replaced at our water plant. DPW also is assisting with the cleanup at the community garden as their season comes to an end. Leaf pickup will occur at the end of November.

The Cultural and Heritage Association is again hosting a pumpkin decorating event at the cottage museum on 10/26 and all are welcome.

Mr. Gabriel – Rat control is important and you need to be sure that you are using the right professionals so that other animals are not harmed.

Our Police Department issued 86 summons for the month of September and 620 for the year to date.

Our Fire Company thanks Toms River for providing approximately \$250,000.00 of new radio equipment to the company at no cost.

All of us have noticed the smoke, several brush fires are burning around Ocean County and they will continue until we see some rainfall.

Mr. Weber - I have sympathy for those in the Borough who have had to deal with rats, it is unpleasant but as the Mayor said we all have to work together and communicate and the problem will be solved.

I applaud the recent walk and bike to school event run by the Elementary School and we thank our Police Department for their support of the event.

Mr. Zabarsky – At the request of Mayor Doyle, I have been in touch with the Ocean County Board of Health and I will be meeting with them tomorrow to discuss any assistance that they can provide in locating rat habitats. I will provide a contact and list of services to Mayor Doyle.

MAYOR DOYLE INTRODUCED THE COUNCIL MEMBER REPORTS:

Mr. Fumo – Our First Aid Squad has received 167 calls for service this year, their response rate is near ninety percent. The Squad did an excellent job providing EMS coverage for Sailfest and we thank Manchester and South Toms River EMS for providing staffing and equipment as back up.

Our Fire Company had another very successful and well attended Labor Day Games and thanks to all who volunteer and participate to make it a great event. The Fire Company reminds everyone that Trucktoberfest is upcoming on October 12th starting at 11 AM, all are welcome.

Mr. Gabriel – As we memorialized on tonight's agenda, two of our Class II part time Officers resigned and moved on to other full time opportunities and we thank them for their service to the Borough and wish them well in their new positions. Our Officers continue with traffic and parking enforcement efforts and fifty nine summons were issued in the past month.

Mr. Weber – Our Elementary School is open for the fall and Back to School Night will take place on September 12th. They will celebrate Veterans Day in front of the school on November 11th and all are welcome to attend.

Betsy Hyle will provide a report on the work of the Friends of the Library Committee for the Governing Body.

Ms. Pendleton – DPW continues with the Boardwalk replacement project with more lumber being delivered this week. DPW responded to a waste water lift station pump failure on West End Avenue and one of the two pumps was replaced. DPW has begun a project to replace the windows at the Borough Office to improve our energy efficiency in heating and cooling.

Our Cultural and Heritage Association will host a pumpkin decorating event for all ages after the success of last years event. Also, their speaker series at the Ocean County Artists Guild continues with a John Adams impersonator and a shipwreck expert upcoming.

Ms. Thompson – The new flooring has been installed in the back office area of our Post Office and it is a great improvement.

Our Environmental Committee had a table at Sailfest and shared some great information on sustainability that we can all use in our own backyards.

Our Community Garden is beginning to wrap15up for the season and clean ups of the beds will be underway.

Our Construction Office has processed permits totaling \$68,523.00 year to date.

Our Code Enforcement Office has sold 1,300 Recreation Badges while completing 35 occupancy inspections and processing 37 zoning applications and 32 tree removal permits.

Mayor Doyle – Our townwide yard sale is taking place on September 21st, please obtain a permit from the office to participate.

Our water meter replacement project is under final review for a start date by the State and we hope have a response within thirty days.

The new fire truck has been ordered and the Borough made a seventy 75% down payment from our cash reserves and the balance will be due upon delivery in two to four years.

Work on our fall road projects will start in the next few weeks with five roads being repaired and repaved (Holly Ave., Lake Drive, Maple Ave., Garden Ave. and Garfield Ave.)

Working with our Librarian (Christine) the Committee has recruited eighteen volunteers who are now helping with programming at the Library.

The Committee acquired a new Nintendo Video Game Set and several new board games using funds that they raised privately.

Their various reading programs continue for adults and children with over one thousand books read during the summer months.

Mayor Doyle – Thanked Ms. Hyle and all of the Committee Members and Volunteers for all that they do to enhance the Library Experience for all of us.
